## TOY PRODUCT RECALLS:

**PRODUCT/FIRM:** "Galaxy Warriors" Toy Figures by Henry Gordy International Inc.

**BRAND/ MODEL:** The "Galaxy Warriors" spaceman figures are about 4 ½ inches tall and come with two accessories. They were sold in various colors including yellow, grey, silver, blue, green, gold, black and red. This product was sold at Family Dollar Stores nationwide from January 2006 through October 2007 for about \$1.



**PROBLEM:** Surface paint on the recalled toys contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should take the recalled toys away from children immediately and return the toy for a full refund. For additional information, contact Henry Gordy International at (888) 790-2700.

**PRODUCT/ FIRM:** Elite Operation Toys by Toys "R" Us Inc.

**BRAND/ MODEL:** The recall involves four military-style Elite Operations toys, including Super Rigs (#1004), Command Patrol Center (#1020), Barracuda Helicopter (#1023), and 3 Pack 8 inch Figures (#1024). The product number is located on the toy's



packaging. This product was sold at Toys "R" Us stores nationwide and [toysrus.com](http://toysrus.com) from July 2007 through October 2007 for between \$10 and \$30.

**PROBLEM:** Surface coating on the toys contain excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumer should immediately take the toy away from children, and contact Toys "R" Us at (800) 869-7787 or visit [www.toysrus.com](http://www.toysrus.com) for a full refund or store credit.

**PRODUCT/ FIRM:** Ribbit Board Games by SimplyFun LLC

**BRAND/MODEL:** The SimplyFun Ribbit board games are sold with five frog-shaped wooden pieces that act as pawns for movement. The wooden pieces are blue, red, green, yellow and lavender in color. These products were sold at SimplyFun independent consultants nationwide from March 2007 to October 2007 for about \$8.



**PROBLEM:** Surface paint on the five frog-shaped wooden pieces contains excess levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately remove the five frog pieces from the game and discontinue using them. In addition, contact SimplyFun at (877)557-7767 or visit [www.simplyfun.com](http://www.simplyfun.com) for a refund or a set of five replacement frogs.

**PRODUCT/FIRM:** Children's Toy Gardening Tools by Jo-Ann Stores, Inc.

**BRAND/ MODEL:** This recall involves the Robbie Ducky children's leaf rake, hoe, broom and spade. "Robbie Ducky™ Garden Collection" is printed on a tag attached to the handle. The rake has a yellow handle with the head of a tortoise and green prongs. The hoe has an orange handle with a caterpillar and a blue blade. The broom has a purple handle with a duck and an orange brush. The spade has a yellow handle with the head of a frog and



a red blade. The tools measure between 27 and 29 inches long. These products were sold at Jo-Ann Fabric and Craft Stores nationwide from January 2007 through September 2007 for about \$7.

**PROBLEM:** Surface paint on the handle of the toy gardening tools can contain excessive levels of lead paint, violating the federal lead paint standards.

**REMEDY:** Consumers should immediately take the recall toy away from children and return them to any Jo-

Ann Fabric and Craft Store for a full refund. For additional information contact Jo-Ann Stores toll-free at (888)739-4120 or visit [www.joann.com](http://www.joann.com).

**PRODUCT/ FIRM:** Go Diego Go Animal Rescue Boats by Fisher-Price Inc.

**BRAND/MODEL:** The toy is an orange and yellow boat that squirts water. Cartoon character Diego is in the driver's seat. "Fisher Price," product number K3413, and date codes between 137-7HF and 223-7HF are marked on the toys. This product was sold at retail stores nationwide from June 2007



through October 2007 for about \$15.

**PROBLEM:** Surface paint on the toys contains excessive levels of lead, which violates the federal standard prohibiting lead paint on children's toys.

**REMEDY:** Consumers should immediately take the recalled toys away from children and contact Fisher-Price at (888)229-0579 or visit [www.service.mattel.com](http://www.service.mattel.com) in order to receive a free replacement toy. Consumers need to return the recalled toys to Fisher-Price.

**PRODUCT/FIRM:** Magnetic Game Pieces sold with "Cars" Themed Backpacks by Global Design Concepts Inc.

**BRAND/MODEL:** The 12 inch "Cars" Backpack was sold with four sealed game pieces that contain magnets. The game pieces included a red plastic car; a blue plastic car; and two red and black plastic disks that have "GAS", "OIL" and "SERVICE" printed in red letters on the black perimeter of the disks.



"Warning: Choking Hazard-Small Parts. Not for children under 3 years" is printed on the back pack hangtag. "Disney Presents a PIXAR film" is printed on the gray vinyl front of the backpack. This product was sold at Target stores nationwide from February 2007 through September 2007 for about \$13.


**PROBLEM:** Small magnets inside the four game pieces that were sold with the "Cars" backpack can fall out of their plastic enclosures. Magnets found by young children can be swallowed or aspirated. If more than one magnet is swallowed, the magnets can attract each other and cause intestinal perforation or blockage, which can be fatal.

**REMEDY:** Consumers should immediately take the recalled game pieces away from young children and contact the Cars Backpack Recall at (877) 848-4070 or visit [www.carsbackpackrecall.com](http://www.carsbackpackrecall.com) for instructions on returning the recalled game pieces for a free replacement "Car" wallet or equivalent product.

**PRODUCT/FIRM:** Toy Pirate Swords by The Gymboree Corp.

**BRAND/MODEL:** This recall involves a toy pirate sword with SKU number 140025491- GYS049. The SKU number is printed on the price tag above the bar code.

The sword is made of plastic, and has a gold-colored handle and a gray plastic blade. The sword is about 19 inches long. This product was sold at Gymboree stores nationwide and its Web site from August 2007 through September 2007 for between \$12 and \$15.



**PROBLEM:** The swords can break, creating a sharp point, which poses a laceration hazard to consumers.

**REMEDY:** Consumers should immediately stop using the swords and return them to any Gymboree store for a full refund. Consumers can also contact Gymboree at (877)499-6932 or visit [www.gymboree.com](http://www.gymboree.com) to receive instructions on returning the swords via email.

**PRODUCT/FIRM:** Tabletop Puppet Theaters by Guidecraft Inc.

**BRAND/MODEL:** The recalled puppet theater has red panels on the front and sides and a chalkboard signboard on the top. The puppet theater measures about 24 inches in length, 6-inches in width and about 28 inches in height. This product was sold at specialty toy stores, gift shops, catalogs and Web sites nationwide from June 2006 through August 2007 for about \$35.



**PROBLEM:** A surface paint on the puppet theater's wooden panels contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled puppet theaters away from children and contact Guidecraft at (888) 824-1308 or visit [www.guidecraft.com](http://www.guidecraft.com) to receive a replacement theater or another product of equal value.

**PRODUCT/FIRM:** Disney™ Deluxe Winnie-the-Pooh 23-Piece Play Sets by J.C. Penney

**BRAND/MODEL:** The recalled play sets consists of 23 pieces including: either a white or black baby doll or assorted Winnie-the-Pooh themed items such as a



diaper bag, blanket, playpen, highchair, swing, stroller, and carrying bags. The products were sold through J.C. Penney catalog, Web site and outlet stores nationwide from August 2005

through August 2007 for about \$40.

**PROBLEM:** Surface paint on the play sets contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should take the recalled play set away from young children immediately and return it to any J.C. Penney store for a full refund. For further information, contact J.C. Penney at (888) 333-6069 or visit [www.jcp.com](http://www.jcp.com).

**PRODUCT/FIRM:** Bendable Dinosaur Toys by Kipp Brothers

**BRAND/MODEL:** The Bendable Dinosaur Toys are about three inches long and come in brown, green or orange/green colors. While the toys were sold in boxes



of 36, consumers may have received these products as a giveaway or promotional item from schools, libraries, church


or community groups. This product was sold in the Kipp Brothers' showroom, catalog and Web site from October 2006 through August 2007 for about \$ 10 per box of 36.

**PROBLEM:** The recalled toys pose a risk of lead exposure to young children.

**REMEDY:** Consumers should take the recalled toys away from children immediately and contact Kipp Brothers at (800) 428-1153 or visit [www.kiptoys.com](http://www.kiptoys.com) for information on returning the toys to the place of receipt for a free replacement toy.

**PRODUCT/FIRM:** Baby Einstein Discover & Play Color Blocks by Kids II Inc.

**BRAND/MODEL:** The recall involves the blue block included with the Baby Einstein Discover & Play Color Blocks, Model 30726 and Model 30881. The blocks are made of soft textures and come in different colors. Only date codes of GE7, GF7, and GG7 are included in this recall. The model number and date code are printed on the labels affixed to the green-colored block. This product was sold at various retailers and



specialty stores nationwide from June 2007 through September 2007 for between \$10 and \$13.

**PROBLEM:** Surface paint on the blue block contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled blue blocks away from children and contact Kids II at (866) 209-6788 or visit [www.kidsii.com](http://www.kidsii.com) to receive a free replacement of the affected block.

**PRODUCT/FIRM:** Wooden Pull-Along Alphabet & Math Blocks Wagons, Wooden Pull-Along Learning Blocks Wagons, 10-in-1 Activity Learning Carts, and Flip-Flop Alphabet Blocks by KB Toys, Inc.

**BRAND/MODEL:** Wooden Pull-Along Alphabet & Math Blocks Wagons and Learning Blocks Wagons have 28 blocks and a pull string. The wagons measure about 7 ½ x13 and have blocks with letters, words, numbers or pictures on them. "First Learning" or "My Kidz" are printed on the products' packaging, along with UPC # 834162002158 or # 834162002165 and were sold from August 2005 to August 2007 for between \$9 and \$13. The 10-in-1 Activity Learning Carts are three dimensional learning



toys with various activities. The cart measures about 17¼ x 16½ x 7¾. First Learning and UPC# 834162002127 are printed on the products' packaging and were sold from August 2006 to September 2007 for about \$30. The Flip-Flop Alphabet Blocks have blocks that flip with letters, words, numbers and pictures on them. The toys measures about 10 1/8 x 10 ¾ First Learning and UPC # 834162001212 are printed on the products packaging and were sold from August 2006 to September 2007 for about \$7. All products were sold at KB Toys stores nationwide.

**PROBLEM:** Surface paint on the toys can contain excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumer should immediately take the recalled toys away from children and return them to any KB Toys retail store for a store credit. For additional information, contact KB Toys at (888)-843-9520 or visit [www.recall.kbtinfo.com](http://www.recall.kbtinfo.com).

**PRODUCT/FIRM:** Laugh & Learn™ Learning Kitchen™ Toys by Fisher-Price Inc.

**BRAND/MODEL:** The recall involves a play kitchen learning toy with a pretend refrigerator, range and sink. The product's item number L5067 is stamped on several



locations on the toy and printed on the product's packaging above the UPC. This product was sold at various retail and toy specialty stores nationwide from May 2007 through October 2007 for about \$70.

**PROBLEM:** Pieces of the faucet or the clock hands can detach, posing a choking hazard to young children.

**REMEDY:** Consumers should immediately take the recalled toys away from children and contact Fisher-Price at (888) 812-7187 or visit [www.service.mattel.com](http://www.service.mattel.com) for a free repair kit.

**PRODUCT/FIRM:** "Skippy" Pool Toys by Swimways Corp.

**BRAND/MODEL:** This recall involves a rubber pool toy shaped like a fish. The fish are blue, purple or green colored and measure 8 ½ inches long by 5 inches wide.



A loop of elastic tubing shaped like a tongue comes out of the mouth of the fish and is used for launching the fish across the water like a slingshot.

"Warning. Do not aim at another person. Made in China" is printed on the bottom of the fish. This product was sold at mass merchandisers and independent pool supply stores nationwide from February 2007 through September 2007 for about \$10.

**PROBLEM:** The elastic tongue of the fish can break and forcefully come out and cut the users' hand during launching of the toy.

**REMEDY:** Consumers should immediately take the toy away from children and contact Swimways at (888) 559-

**4653** or visit [www.swimways.com](http://www.swimways.com) for a free replacement toy.

**PRODUCT/FIRM:** "Big Red" Wagons by Northern Tools & Equipment Co.

**BRAND/MODEL:** The recall wagon has a red painted, steel deck with removable wooden sides. The wheels have ball bearing and air-filled tires. This product was sold through Northern Tool & Equipment catalog, Web site, and retail stores nationwide from July 2007 through September 2007 for about \$60.



**PROBLEM:** Surface paint on the wagon and handle contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled wagon away from children and return it to any Northern Tool store for a free replacement. For additional information, contact Northern Tool & Equipment Co. at **(800) 222-5381** or visit [www.northerntool.com](http://www.northerntool.com).

**PRODUCT/FIRM:** Dragster and Funny Car toy by International Sourcing Ltd.

**BRAND/MODEL:** The recall includes plastic models of a dragster and funny car. The dragster is approximately 22 inches long, black in color with various sponsor decals on the toys. The funny car is approximately 14 inches long and is also black in color. Both models have the ISL logo imprinted on the underside.



These products were sold at National Hot Rod Association (NHRA) events associated with Schumacher Racing, and Matco Tools through door to door sales by its representatives from March 2007 through September 2007.

**PROBLEM:** Surface paint on the wheels and engine of the toys contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the toy away from children, and return it to International Sourcing Ltd. for a full refund or replacement toy. For additional information contact International Sourcing Ltd at **(877) 404-1584** or visit [www.islpromotions.com](http://www.islpromotions.com).

**PRODUCT/FIRM:** Pull-Back Action Toy Cars by Dollar General Merchandising Inc.



**BRAND/MODEL:** The recall involves two styles of "pull and release" toy cars, including a four pack of Super Wheels (UPC# 400016576344) and a two pack of Super Racer cars (UPC# 883788965002). This product was sold at Dollar General stores

nationwide from April 2007 through October 2007 for about \$1 per pack.

**PROBLEM:** Surface paint on the cars contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toy cars away from children and return them to any Dollar General store for a full refund. For additional information contact Dollar General at **(800) 678-9258** or visit [www.dollargeneral.com](http://www.dollargeneral.com).

**PRODUCT/FIRM:** Duck Family Collectable Wind-Up Toy by Schylling Associates, Inc.

**BRAND/MODEL:** The recalled Duck Family consists of a large wind-up duck, which pulls three little ducks. They are made of tin and are primarily yellow in color. This



product sold at specialty toy stores and gift shops nationwide from January 2007 through August 2007 for about \$8.

**PROBLEM:** Surface paint on the ducks contains excessive levels of lead, which violates the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toy away from children and contact Schylling at **(800) 767-8697** or visit [www.schylling.com](http://www.schylling.com) to receive a refund or free replacement toy.

**PRODUCT/FIRM:** Winnie-the-Pooh Spinning Top by Schylling Associates Inc.



**BRAND/MODEL:** The recalled spinning top is primarily metal and has wooden handles. The top is printed with Winnie-the-Pooh characters. Tops with plastic handles are not included in this recall. This

product was sold at specialty stores and gift shops nationwide from April 2003 through November 2003 for about \$12.

**PROBLEM:** Surface paint on the wooden handle of the top contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toy away from children and contact Schylling at **(800) 767-8697** or visit [www.schylling.com](http://www.schylling.com) to receive a refund or free replacement toy.

**PRODUCT/FIRM:** Dizzy Ducks Music Box by Schylling Associates Inc.

**BRAND/MODEL:** The Dizzy Ducks Music Box is a wind-up music box with ducks that spin as music plays. This product was sold at specialty stores and gift shops nationwide from March 2007 through October 2007 for about \$12.



**PROBLEM:** Surface paint on the wooden base of the music box

contains excessive levels of lead, which violates the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toy away from children and contact Schylling at **(800)767-8697** or visit [www.schylling.com](http://www.schylling.com) to receive a refund or free replacement toy.

**PRODUCT/FIRM:** "Robot 2000" collectable tin robot by Schylling Associates Inc.

**BRAND/MODEL:** The "Robot 2000" is a battery-operated, tin robot standing 12 inches tall. It has a red light on the head and chest panels that open. This product was sold at specialty toy stores and gift shops nationwide from October 2006 through September 2007 for about \$25.



**PROBLEM:** Surface paint on the robot contains excessive levels of lead, which violates the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toy away from children and contact Schylling at **(800)767-8697** or visit [www.schylling.com](http://www.schylling.com) to receive a refund or free replacement toy.

**PRODUCT/FIRM:** Aqua Dots by Spin Masters

**BRAND/MODEL:** The recalled toy is a craft kit which allows children to create various multi-dimensional designs using small colored beads. The beads fuse together when sprayed with water.



The recall applies to all models of Aqua Dots. The product is available in various different kits with accessories such as a drying fan, applicator pen, design templates for the bead, and spray bottle. The product is labeled for ages 4+ up and sold at mass merchandisers nationwide from April 2007 through November 2007 for between \$17 and \$30.

**PROBLEM:** The coating on the beads that causes the beads to stick to each other when water is added contains a chemical that can turn toxic when ingested. Children who swallow the beads can become comatose, develop respiratory depression, or have seizures.

**REMEDY:** Consumers should immediately take the recalled toy away from children and contact Spin Master at **(800) 622-8339** or visit [www.aquadotsrecall.com](http://www.aquadotsrecall.com) to return the product for free replacement beads or a toy of equal value.

**PRODUCT/FIRM:** Curious George Plush Dolls by Marvel Toys



**BRAND/MODEL:** This recall involves Curious George 12 inch plush dolls with a plastic face. The dolls are dressed to represent five various themes: birthday, fireman, sweet dreams, tool time and tool time with a

soft face. The plush dolls were sold with a Curious George storybook or activity book. The following product and SKU numbers are printed on the packaging: Birthday 90253/8-83199-90253-5, Fireman 90246/8-83199-90246-7, Sweet Dreams 90247/8-83199-90247-4, Tool Time 90251/8-83199-90251-1, Tool Time (soft face) 90251/8-83199-90251-1. These products were sold at toy and discount department stores nationwide from December 2005 through August 2007 for about \$15.

**PROBLEM:** Surface paint on the toy's plastic face and construction hat contains excessive levels of lead, which violates the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled toys away from children and contact Marvel Toys at **(800) 352-2064** or visit [www.regen.com/curiousgeorge](http://www.regen.com/curiousgeorge) to receive a full refund.

**PRODUCT/FIRM:** Snow and Sand Castle Kits by Paricon Inc.

**BRAND/MODEL:** The recall castle kit consists of three red plastic block makers. Only the largest block maker in the set is included in the recall. The largest block maker measures about 19 inches in length and 5 inches in width. Smaller block maker blocks and castles kits with the letter "A" on the inside of the large block maker are not included in



this recall. This product was sold at L.L. Bean retail stores nationwide, catalogs and internet from September 2007 through October 2007 for about \$30.

**PROBLEM:** The largest plastic castle block maker in the kit could crack at the handle during use, creating sharp edges that can pose a laceration hazard to young children.

**REMEDY:** Consumers should stop using the large blocks and immediately take these recalled toys away from children. Letters will be sent to each customer with a replacement large castle block maker and a return mailer enclosed. In addition the notice will be posted in L.L. Bean retail stores and on its website. Customers can return the kit to any retail store for a replacement. For additional information, please contact Paricon at (800) 873-8452 or visit [www.llbean.com](http://www.llbean.com).

**PRODUCT/FIRM:** Shaving Paint Brushes by Discount School Supply

**BRAND/MODEL:** The recall involves a set of six "shaving-style" brushes, which are about 4-inches long.



The brushes' handles are painted blue, purple, orange, yellow, lime-green and pink. The item number #SHVBRSH is printed on the product's packaging. Brush sets with handles

in brown, dark blue, red, green, blue/black are not

included in the recall. The recalled brushes were also included with the "BioColor® Foam Paint Starter Kit" and "Colorations® Foam Paint Starter Kit." These products were sold at Discount School Supply's catalog and Web site from May 2004 through August 2007 for about \$60.

**PROBLEM:** Surface paint on the brush handles can contain excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should stop using the brushes immediately and contact Discount School Supply at (800) 293-9314 or visit [www.discountschoolsupply.com](http://www.discountschoolsupply.com) to receive a free replacement brush set.

**PRODUCT/FIRM:** DesignWare® Confetti Burst by American Greetings Corp.

**BRAND/MODEL:** The recalled product contains confetti in plastic bags. When the bags are inflated, consumers squeeze the bag and confetti bursts out. Each package contains six confetti bursts. These products were sold at discount, toy, drug, grocery, party, and specialty/gift stores nationwide from December 2003 through September 2007 for about



\$3.

**PROBLEM:** The surface paint on the individual bags of confetti contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled confetti burst away from children and contact American Greetings at (800) 777-4891 or visit [www.ag.com](http://www.ag.com) to receive a coupon redeemable wherever American Greetings' products are sold.

**PRODUCT/FIRM:** Tot Tower toy blocks by eeBoo Corp.

**BRAND/MODEL:** The recalled Tot Tower is sold with 10 blocks ranging from 6x6 inches to 1.5x1.5 inches.



The cardboard blocks are covered in a plastic laminate firm. The blocks have various images and themes including Things I Know New; Garden Fairies; Hardware Stores; Around the Land; Read-To-Me; Animal Sounds; Animal Alphabet; ABC; and Nursey

Friends. "Tot Towers" and "eeBoo Corporation" are printed on the product's packaging. This product was sold at specialty and gift shops nationwide from January 2003 through September 2007 for about \$20.

**PROBLEM:** The plastic covering on the toy blocks can detach, posing a choking hazard to children.

**REMEDY:** Consumers should immediately take the recalled toy away from children, and return it to the place of purchase for a full refund, or contact eeBoo Corp. at (800) 791-5619 or visit [www.eebo.com](http://www.eebo.com) to receive a replacement toy.

**PRODCUT/FIRM:** Super Magnets by Man's Training Company.

**BRAND/MODEL:** The ½ inch toys are shaped and painted to resemble panda bears. A small magnet is attached to the bottom of the toy. "Super Magnets" and the MTC logo are printed on the front of the packaging.



The magnet toys are sold eight to a package. This product was sold at dollar and gift stores nationwide from September 2005 through November 2007 for about \$1.

**PROBLEM:** The magnet attached to the bottom of a small toy panda can detach. If swallowed or aspirated by young children, the magnets can attract each other internally and cause intestinal perforations or blockages, which can be fatal.

**REMEDY:** Consumers should take the recalled toy away from children immediately and return them to the store where purchased for a full refund. For additional information, contact MTC at (800) 388-7228.

**PRODUCT/FIRM:** Holiday Cosmetics Stuffer Bears by Victoria's Secret

**PRODUCT/FIRM:** Bunk Beds by Hooker Furniture Corp.

**BRAND/MODEL:** The recalled bunk beds come in twin-over-twin, twin-over-full and loft beds with the following



model names: "Albany Park," "Swedish Accents," "Mariner's Landing," and "Chelsea's Place". The bunk beds come in cherry, white, and black finishes. Some of the bunk beds are also made of metal. This product was sold at

**PROBLEM:** The bunk beds have gaps between parts of the upper bunk that could allow a child's body to pass through but not a child's head. This poses an entrapment of strangulation hazard to children and exceeds the space allowed by the federal bunk bed safety standard.

**REMEDY:** Consumer should not allow children to use the recalled bunk beds and contact the retailer where

**PRODUCT/FIRM:** Codeena Princess Children's Metal Jewelry by Codee International

**BRAND/MODEL:** This recall involves the Codeena Princess children's jewelry. Only jewelry with numbers KS1367SS and KS1369SCP are included in the recall. The item number is printed on the back of the packaging. The children's jewelry sets were sold in a variety of sets including pink or white pearl-like necklaces, bracelet and earring or ring combinations. Some sets have studded charms dangling on the bracelets and the necklace. This product was sold at discount stores nationwide from September 2005 through August 2007 for about \$5.




**PROBLEM:** The recalled jewelry contains high levels of lead. Lead is toxic if ingested by young children and can cause adverse health effects.

The date codes are located on the back of the lion's head, above the Infantino® logo. Lion teethers with other date codes are not included in this recall. This product was sold at Babies "R"



Us, Pottery Barn Kids and other specialty stores nationwide from June 2006 through December 2007 for about \$5.

**PROBLEM:** The plastic nose can detach, posing a choking hazard to young children.

**REMEDY:** Consumers should take the recalled toys away from young children immediately and contact Infantino® at **(888) 808-3111** or visit [www.service.infantino.com](http://www.service.infantino.com) for a replacement teether or a product of equal value.

**PRODUCT/FIRM:** Giant Measuring Chart by Discount School Supply.

**BRAND/MODEL:** The Giant Grow Chart measures a child's growth with a giant yellow ruler-shaped plastic chart. The grow chart also has a picture of a bean stalk painted on it from top to bottom. This product was sold by Discount School Supply catalogs and the company's Web site from August 2000 through August 2007 for about \$10.

**PROBLEM:** The paint on the grow chart contains excess levels of lead, violating the federal lead paint standard.



**REMEDY:** Consumers should stop using the chart immediately and contact Discount School Supply at (800) 919-5242 or visit [www.discountschoolsupply.com](http://www.discountschoolsupply.com) to receive a credit or refund.

**PRODUCT/FIRM:** Jewel brand girls' hooded sweatshirts by Liberty Apparel Co. Inc.

**BRAND/MODEL:** The Jewel brand girls' zippered hoodie sweatshirts have various designs on the front and were sold in two styles: the "Big Heart" zip-up long sleeve hoodie sweatshirts (style# J2173k/sk) in black, light pink and purple colors, and the "Small Stars" long sleeve hoodie jacket sweatshirts (style # J2174k/sk) in green, khaki, navy and orange colors. Both styles were sold in small, medium, large and extra-large sizes. This product was sold at Marshalls and other specialty children's clothing retailers nationwide from August 2007 through November 2007 for about \$10.



**PROBLEM:** The garments have a drawstring through the hood, which can pose a strangulation hazard to children.

**REMEDY:** Consumers should immediately remove the drawstring to eliminate the hazard or return the sweatshirts to either the place of purchase or Liberty Apparel for a full refund. For additional information, call Liberty Apparel Co. collect at (212) 768-3030.

**PRODUCT/FIRM:** Sterling Sliver Teething Rings by Empire Silver Company

**BRAND/MODEL:** The recalled sterling silver teething rings were sold in three styles: single ring with ball, single ring with heart and ball, and three rings with ball. The hollow ring has small beads inside that make a rattling sound and a ball soldered between the rings. These products were sold at independent jewelry, gift, specialty and department stores nationwide during November 2007 for between \$50 and \$120.



**PROBLEM:** The silver ball that holds the ring in place can separate and release the beads inside. This poses a choking and aspiration hazard to infants.

**REMEDY:** Consumer should immediately take the teething rings from infants and return them to the store where purchased for a full refund or replacement. For additional information contact Empire Silver Company at (800) 255-9475 or visit [www.empiresilver.com](http://www.empiresilver.com).

**PRODUCT/FIRM:** "Warmest Jacket" Boys' Jackets by Gap Outlet

**BRAND/MODEL:** The jackets are hooded, zip in front, and have a drawstring at the waist. They were sold in navy and gray in multiple children's sizes. "Gap Outlet" is printed on a label at the neck. Style number 513573 is printed on a white label sewn behind the sizes and product care label near the neckline. This product was sold exclusively at Gap Outlet



stores nationwide from September 2007 through December 2007 for about \$50.

**PROBLEM:** The jackets have a waist drawstring with a toggle that could become snagged or caught in small spaces of doorways, which can pose an entrapment hazard to children.

**REMEDY:** Consumers should stop wearing the jacket immediately and return it to any Gap Outlet store for a full refund. Consumers who return the jacket before April 30, 2008 will also receive a \$5 appreciation card. Consumers choosing to keep the jacket should immediately remove the drawstring to eliminate the hazard. ## NEWS FROM the CPSC

The U.S. Consumer Product Safety Commission (CPSC) is warning families nationwide about the dangers of placing infants on air mattress. Air mattresses are too soft for use with sleeping infants. Never place infants to sleep on air mattresses or other soft surfaces (such as water beds and adult beds), which are not specifically designed or safe for infant use.

Since 2002, the CPSC has received reports of sixteen tragic deaths of mostly infants younger than eight months of age who were placed to sleep on air mattresses. Of those reports, eleven infants suffocated in a face down position on an air mattress and five died due to suffocation after falling into gaps between the mattress and bed frame or mattress and adjacent furniture or wall.

Twin and queen sized inflatable mattresses are intended for adults and older children. Even properly inflated air mattresses are usually too soft for infants to maintain a clear airway. Air leaks and under inflation also contribute to fatal incidents.

To ensure where your baby sleeps is as safe as possible, always place your baby to sleep on his or her back to reduce the risk of SIDS. Never place a baby to sleep on an adult bed. Infants can suffocate on bedding or can become entrapped between the mattress and bed or mattress and wall. When using a crib, make sure it meets current safety standards, has a firm, tight-fitting

mattress and tight-fitting bottom sheet. Finally, when using a portable crib or play yard, be sure to use only the mattress or pad provided by the manufacture.
