## PRODUCT RECALLS



**PRODUCT/FIRM:** Children's Pillowfort Weighted Blankets by Target

**DESCRIPTION:** This recall involves Pillowfort Weighted Blankets. The

blankets weigh 6 pounds, measure 60 inches long and 40 inches wide, and have a removable, waterproof, washable cover. The blankets come in eight prints or colors including unicorn white, space navy, pink, blue, gray, buffalo plaid red, blue constellation, and unicorn pink. Item numbers 097-02-0140 (Unicorn - White), 097-02-0148 (Space Navy), 097-02-0361(Pink), 097-02-0363 (Blue), 097-02-0364 (Gray), 097-02-1603 (Buffalo Plaid – Red), 097-02-3904 (Blue Constellation) and 097-02-3905 (Unicorn – Pink) are printed on the fabric tag attached to the removable covers of the blankets.

**REMEDY:** CPSC and Target are urging consumers to stop using the recalled weighted blankets immediately and contact Target for a refund.

PRODUCT/FIRM: Pacific Kids' Igniter and Pacific Bubble Pop 20-Inch Bicycles by Pacific Cycle; Sold Exclusively at Target DESCRIPTION: This recall involves two models of 20" Pacific Kids' Bicycles. The Pacific Igniter has red

with white and black accent colors and the word "Igniter" on the downtube and the Pacific Bubble Pop has pink with blue and black accent colors and the words "Bubble Pop" on the downtube. The model numbers 201230TG, 201231TG are located on the seat tube where it meets the bottom bracket.

**REMEDY:** Consumers should immediately stop riding the recalled bicycles and contact Pacific Cycle to receive a free repair kit, which will contain a bolt, nut, washer, and grease packet with instructions to apply grease to the bolt. **CONSUMER CONTACT:** Consumers may contact Pacific Cycle by phone at 877-564-2261 from 7:00 AM to 6:00 PM Monday through Friday, by email at customerservice@pacific-cycle.com, or online at www.pacific-cycle.com/safety-notices-recalls.



**PRODUCT/FIRM:** Thornhill Baby Cribs by Crate and Barrel

**DESCRIPTION:** This recall involves Thornhill Dark Brown and Natural Baby Cribs. The cribs have a dark brown

wash finish and gold-capped feet. The crib's model number is 304-903 and is located on the mattress support board.

**REMEDY:** Consumers should immediately stop using the recalled cribs and contact Crate and Barrel for a full refund or free replacement. Crate and Barrel is contacting all purchasers directly.

**PRODUCT/FIRM:** Discovery Cubes Animal Hide and Seek Activity Toys by HABA USA

**DESCRIPTION:** This recall involves the Discovery Cubes Animal Hide and Seek activity toys. The toys are in the shape

of a house made with multicolored fabric. The toy animals in the house include a fox, a hedgehog and a mouse. The toys have different pockets and rings. The model number 306684 can be found on the sewn in label inside the house and on the packaging.

**REMEDY**: Consumers should immediately take the recalled toy away from the child, cut the toy in half with a pair of scissors, take a photo of it, and discard it in the household trash. Contact HABA to receive a \$30 refund or gift card. Email a photo documenting that the toy has been destroyed along with your contact information to recall@habausa.com to receive the refund. HABA is contacting all known purchasers.

**PRODUCT/FIRM:** Cloud Island 4-Piece Plush Toy Sets by Target

**DESCRIPTION:** This recall involves Cloud Island 4-Piece Plush Toy Sets. The vehicles are a soft, knitted construction and include a blue car, a yellow bus, a red

tractor, and a green truck each with a rattle inside. The vehicles measure approximately 3 inches (H) x 3.5 inches (W) x 6 inches (D). Item number 030-02-1042 is printed on the fabric tag attached to the bottom each vehicle.

**REMEDY**: Consumers should immediately take the recalled plush toys away from young children and return them to any Target store for a full refund or contact Target to receive a prepaid return label to return the toy set by mail.

**PRODUCT/FIRM:** Toddler's Stainless Steel Bottles and Cups by Green Sprouts **DESCRIPTION:** This recall

involves 6 oz and 8 oz Green Sprouts Stainless Steel cups and bottles with tracking numbers 29218V06985, 35719V06985, and 33020V06985, which can be found on the bottom of the base. The recalled double-walled stainless steel bottles were sold in aqua, pink, green, and navy colors with one of three closure options: (1) a silicone sippy spout with a colored plastic lid, collar, and handle; (2) a silicone sippy spout and a straw spout with colored plastic lid, collar, and handle; or (3) a silicone straw with plastic screw-on flip cap. The tracking number is printed on the bottom base.

**REMEDY:** Consumers should immediately take the recalled stainless steel bottles and cups away from children. The base of the bottles and cups should be discarded. The plastic and silicone components can be kept as they are unaffected by this recall. Contact Green Sprouts for a full refund in the form of store credit or your money back. Green Sprouts is contacting all known purchasers directly.

**DESCRIPTION:** The recall involves Bentex children's clothing sets in nine different Disney themed styles. The item and batch numbers are printed on the clothing neck or side label. The following styles are included in the recall: Jersey Leggings Set -

G9P6456M, Bike Shorts Set - G1E2125MI, Girls Shorts Set - SP2247971DC, Girls Shorts Set - SP2246088DS, Boys Shorts Set - B2E6459LN, 3 Pack Shorts Set - B2E6919MM, 3 Pack Pants Set - B2P6920MM, Children's Shorts Set - B2E5094PH, and Children's Leggings Set - G2P6361MI.

**REMEDY:** Consumers should immediately take the recalled children's clothing sets away from children and contact Bentex for instructions on how to return or dispose of the recalled clothing to receive a full refund.

PRODUCT/FIRM: Children's Rainbow Stacking Toys by Professor Puzzle DESCRIPTION: This recall involves Professor Puzzle's rainbow stacker 6-piece toys. The 7-inch or 11-inch

wooden toys were sold in two pastel color combinations: Green/blue or pink/blue. Model numbers 8739 or 8741 and date code 04/22 are printed on a sticker on the underside of the small center piece of the toy and on the back of the packaging.

**REMEDY:** Consumers should immediately take the recalled stacking toys away from children, stop using them and contact Professor Puzzle for instructions on how to remove and dispose of the sticker or to receive a refund of \$20 for the 11-inch toy and \$15 for the 7-inch toy. Consumers will be asked to return the product in a prepaid mailer. Consumers can also return the product to the retail store for a full refund of the purchase price.

PRODUCT/FIRM: Infant's Yellow Footed Fleece Pajamas with Animal Graphic by The William Carter Company DESCRIPTION: This recall involves Carter's infant's one-piece fleece, footed pajamas. The recalled pajamas are

yellow with an all over heart design and a pink animal graphic. They were sold in children's sizes 12M, 18M, and 24M. Style number 10102410 is printed on the front of the care tag sewn on the inside of the pajamas, and the UPC number is printed on the back of the same care tag. The UPC numbers included in the recall are 195861313861, 195861313878, and 195861313885. The style number and UPC number are also printed on the price tag.

**REMEDY:** Consumers should immediately take the recalled infant footed fleece pajamas away from children and return them to a Carter's store location for a full refund in the form of a gift card. Consumers can also contact Carter's to request a free return label and envelope to return the pajamas for a refund in the form of an electronic gift card.

**PRODUCT/FIRM:** Single-to-Double Strollers by Mockingbird

**DESCRIPTION:** This recall involves Mockingbird Single-to-Double Strollers. Mockingbird Single-to-Double Strollers are made of aluminum and are black or silver in

color. The seats are black, and the canopies are available in black, light blue, dark blue, pink and light green. The recall includes only Mockingbird Single-to-Double Strollers with a lot number between 20091 and 22602.

The lot number is a five-digit number that can be found on the white product label located on the inner left side of the stroller frame near the top of the basket.

**REMEDY:** Consumers should immediately stop using the recalled Single-to-Double strollers and contact Mockingbird to receive a free frame reinforcement kit, which includes two frame clamps that attach to the sides of the stroller to reinforce the frame. Mockingbird is contacting all known purchasers directly.

Children's Ramp Sets by BS Interactive **DESCRIPTION:** This recall involves Stashables-branded finger skateboard ramp sets. Each 6 or 11-piece toy set consists of miniature skateboard plastic

ramps with graffiti art and include a mixture of toy skates, skateboards, caster boards, scooters and bicycles. Only the scooters and skateboards are included in this recall. Stashables, 5+ years and the number of pieces is printed on the front of the product packaging. Batch number 18112021 is printed on the bottom left corner of both products' front panel.

**REMEDY:** Consumers should immediately take the recalled miniature scooters and skateboards away from children and contact BS Interactive to receive free replacement scooters and skateboards, including free shipping. Consumers will be asked to submit a photo of the disposed recalled scooters and skateboards. BS Interactive is contacting all known purchasers directly.

**DESCRIPTION:** This recall involves the Tangame busy houses. The Montesssori toy house is a wooden activity center cube-shaped toy that measures 20

inches high by 12.5 inches wide by 12.5 inches deep with storage. It has four, black caster wheels at the bottom. Activities on the sides of the house include a xylophone, an abacus, a telephone, a clock, a wheel, lights, gears, latches and others.

**REMEDY:** Consumers should take these recalled toys away from young children immediately and contact Tangame Toys for information on how to dispose the product or components for a full refund.

**PRODUCT/FIRM:** Bolt Foldable Children's Scooters by Anker Play Products **DESCRIPTION:** This recall involves Bolt Foldable Scooters for children. They are painted black with a blue or purple standing platform.

"APPLLC120806218142" is printed in white letters on the top left corner of the blue or purple standing platform. "Bolt" is printed on a blue or purple sticker on the front of the scooter in white lettering. The scooter measures approximately 23 inches by 3.75 inches by 20 inches when assembled and weighs about 2.7 pounds.

**REMEDY:** Consumers should immediately take the recalled scooters away from children, stop using them and contact Anker Play Products for a full refund.

**DESCRIPTION:** This recall involves all Goalsetter Adjustable and Fixed Wall Mount Series and GS Baseline Series 72-inch, 60-inch, 54-inch, and 48-inch wall-mounted

goal systems. The basketball goals have a white Goalsetter logo (a white basketball to the left of the word "Goalsetter" printed in the lower left corner of the backboard).

**REMEDY:** Consumers should stop using the recalled wall-mounted basketball goals immediately and contact Goalsetter for free removal of the basketball goal with a full refund or a free inspection of the installed wall-mounted basketball goal and free installation of an additional safety bracket. Goalsetter is contacting all known purchasers directly.

**DESCRIPTION:** This recall involves all Tesla Cyberquad for Kids by Radio Flyer, Model Number 914. The

Cyberquad features a full steel frame, cushioned seat and adjustable suspension with rear disk braking and LED light bars. The Cyberquad is powered by a lithium-ion battery with up to 15 miles of range and a top speed of 10 mph.

**REMEDY:** Consumers should immediately stop using the recalled Cyberquad and contact Radio Flyer for a full refund. Consumers can obtain a full refund by removing the product's motor controller and sending the controller back to Radio Flyer via a prepaid envelope. Removing the motor controller will permanently disable the Cyberquad.

Radio Flyer is contacting all consumers directly. **PRODUCT/FIRM:** Children's Butterfly Net Sets and Army Action Figure Playsets by Juvo Plus

**DESCRIPTION:** This recall involves Juvo Plus' insect-catching butterfly net

sets and Blue Panda/Soldier Force Playset army action figure playsets. Each butterfly net set was sold with three nets in three different colors: blue, green and orange. The butterfly net has a telescoping handle that extends up to 34 inches with a rubber grip at the end that matches the color of the net. When not extended, the net measures 15 inches long. The net measures 8 inches deep. Juvale is printed on the product packaging. Each army action figure playset comes with 300 individual army-styled action figures, displays and set pieces including but not limited to: soldiers, tanks, planes and flags. The eight SWAT figures measure about 3.5 inches tall. The eight SWAT Team figures have flexible joints. The other soldiers measure about 1.5 inches tall. The set comes with a plastic bag for storage and transport that has green trim, zipper closure and green handles on top. "Blue Panda," "Military Playset" and "300 PCS," or "Soldier Force Playset" and "300 PCS" are printed on a cardboard sleeve located inside the plastic bag.

**REMEDY:** Consumers should immediately take the recalled butterfly net sets and the action figure playsets away from children and contact Juvo Plus for a full refund of the purchase price. Consumers will be asked to register their butterfly net sets and submit a photo of the disposed product with the nets cut and the handles initialed and dated. For the action figure playsets, consumers will be asked to register their product, certify that the product will no longer be used and has been disposed as directed, and submit a photo of the disposed product. Upon receipt of the photo and validation, consumers will be issued a full refund of the purchase price. Juvo Plus is contacting all known purchasers directly or through a third party as applicable.

orange on the side. A pineapple-shaped hopper that holds

the gellets attaches on the top and a black on/off switch is located at the back of the blaster.

**REMEDY:** Consumers should immediately stop using the recalled Gel Blaster SURGE Model 1.0 and contact Gel Blaster to receive a prepaid mailer to return the product and receive a full refund. Gel Blaster is contacting known purchasers directly.

**PRODUCT/FIRM:** Baby Blankets by JX **DESCRIPTION:** This recall involves Mittal International chenille weave baby blankets sold in cream, blush, taupe, mint, gray, lavender, ivory, ochre, pale blue, sage and terracotta colors with a "Made in India" hangtag

with an elephant design. The blankets have fringe around the edges and measure about 32 inches by 40 inches.

**REMEDY:** Consumers should immediately stop using the recalled baby blankets and return them to any HomeGoods, Marshalls or T.J. Maxx store for their choice of a full refund or store credit. Alternately, consumers can contact TJX for instructions on how to submit a photo of the recalled blanket, along with their contact information and written confirmation that they will discard the blanket to receive a full refund or a refund in the form of a store gift card.

**PRODUCT/FIRM:** Children's Sleepwear; Imported by Jammers Apparel Group; Sold Exclusively at JCPenney

**DESCRIPTION:** This recall involves Dots & Dreams Dollie & Me-branded

children's nightgowns made of 100% polyester. The short-sleeved nightgowns were sold in rainbow print on a mint-green background and have "Wknd" screen-printed on the front of the garment. They were sold in five sizes (XXS, XS, S, M, L) and were accompanied by a matching doll-size nightgown, screen-printed with "No Glitter No Party." "Dots & Dreams," "Made in China," "CA#29504" and "RN#93166" are printed on the pajama's neck label.

**REMEDY:** Consumers should immediately take the recalled sleepwear away from children and contact Jammers Apparel Group for a full refund. Consumers who purchased the nightgowns will be asked to destroy the

garments by cutting them in half and send the recalling firm a photo of the destroyed garment. Upon receipt of the photo, consumers will be issued a full refund of the purchase price.

**DESCRIPTION:** This recall involves U.P. Fashion children's rings. The ring is gold with a large faux pearl. The large pearl

comes in multiple colors. Small white crystals surround the pearl on the gold base.

**REMEDY:** Consumers should immediately take the recalled rings away from children and contact U.P. Fashion for information on how to properly dispose of the rings and receive a full refund.

**DESCRIPTION:** This recall involves the Early Learning Centre Little Senses Lights and Sounds Shape Sorter toys. The toy has a white and gray base, holds six colored, shaped pieces with lights, and makes sounds and music. "Little Senses" is printed on the side of the base. The toy was marketed for children between ages 6 to 36 months of age. The item code for the sorter toy 82756 is located on the base of the main unit.

**REMEDY:** Consumers should immediately take the recalled toys away from children, stop using the recalled red cube, discard them, and contact Addo Play for a free replacement red cube. The shape sorter toy can be used without the red cube.

**PRODUCT/FIRM:** Children's Sleepwear; Imported by Ekouaer; Sold Exclusively at Amazon.com

**DESCRIPTION:** This recall involves Ekouaer children's bathrobes made of 65% cotton and 35% polyester. The hooded bathrobes were sold in short-

sleeves and long-sleeves and in sizes 110, 120, 130, 140 and 150. The long-sleeve bathrobes were sold in 11 colors: aqua blue, Christmas pattern, grid pattern, navy blue, pink, pink rainbow, purple, purple rainbow, rose red, red and sky blue. The short-sleeve bathrobes were sold

in seven colors: aqua green, navy, pink, purple, red, rose and white.

**REMEDY:** Consumers should immediately take the recalled sleepwear away from children and contact Ekouaer for a full refund. Consumers who purchased the bathrobes will be asked to destroy the garments by cutting them in half and send the recalling firm a photo of the destroyed garment. Upon receipt of the photo, consumers will be issued a full refund of the purchase price. Ekouaer and Amazon will contact all known purchasers.
