PRODUCT RECALLS



PRODUCT/FIRM: Zoom 360 Ultralight Jogging Strollers by Joovy DESCRIPTION: This recall involves Zoom 360 Ultralight jogging strollers with SKU 8060, 8061, 8067 and 8069 and a batch number between March 2020 (03-XX-20) and October 2020

(10-XX-20). The strollers were sold in black, blueberry, charcoal and red colors and weigh about 26 lbs. The stroller label on the inside leg contains the SKU and batch numbers. "Joovy" is written across the front of the stroller and "Zoom Ultralight" is written on the parent organizer attachment on the bottom of the stroller. See Joovy's video at https://vimeo.com/574693044/09c3d0418c to install the repair.

REMEDY: Consumers should immediately stop using the recalled strollers and contact the firm for a free repair kit to replace the front wheel fork bearing. Joovy is contacting all known purchasers directly.

PRODUCT/FIRM: Baby Long Sleeve Wiggle Sets by Hanna Andersson DESCRIPTION: This recall involves the Baby Long Sleeve Wiggle Set, the style number 66938 is written on the main label at the neck of the top. Metal snaps

are located at the crotch of the top. It's a 100% cotton long-sleeve top and pant set sold in Petal Pink with a pink floral pattern; Golden Hour with black and white polka dots and gold trim; and Navy Blue with a green turtle print and navy trim. The set comes in U.S. sizes from zero months to three years and Euro sizes 50-90.

REMEDY: Consumers should immediately stop using the recalled Baby Long Sleeve Wiggle Set and contact Hanna Andersson for a full refund. Hanna

Andersson will be providing postage-paid labeling to consumers for the return of the product for a full refund. Hanna Andersson is contacting all known purchasers directly.

PRODUCT/FIRM: Youth Helmets by ABUS

DESCRIPTION: This recall involves the ABUS ACM (MountZ) youth medium sized helmets with

about a 21 inch circumference and attached chin strap. The recalled helmets were sold in velvet black and polar white colors. "ABUS" is printed on the left side, front and back of the helmets. The model ACM (MountZ) with the manufactured date of March 2020 or October 2020, is printed on a label on the inside of the helmet.

REMEDY: Consumers should immediately stop using the recalled helmets and return them to ABUS's Recall Administrator, Sedgwick, free of charge, for a full refund.

PRODUCT/FIRM: Playsets with Wooden Roof by Backyard Play Systems

DESCRIPTION: This recall involves Backyard Play Systems outdoor playsets

with a wooden roof. The wooden roof is included with home play equipment marketed under the brand names Yardline Play Systems (models Turbo Racer, Cloud Racer) and Gorilla Playsets (models Captain's Fort, Fort Highlander). The playsets include a solid wood roof with a lookout window, slides, swings, a rock-climbing wall and other play features.

REMEDY: Consumers should immediately stop using the recalled playsets and contact Backyard Play Systems for a free repair kit which includes replacement wood parts, hardware and instructions. If a consumer is unable or does not want to do the repair themselves, Backyard will send a representative to perform the repair for them at no

charge. The firm is contacting all known purchasers directly.

PRODUCT/FIRM: Children's Robes by Mark of Fifth Avenue DESCRIPTION: This recall involves Star Art in Linen-branded children's 100% polyester robes. The robes were sold in six children's sizes 2, 3-4, 5-6, 6-7, 7-

8, and 10-12 in the following seven colors: black, navy, blue plaid, red plaid, red, royal blue, and gray. The long-sleeved robes have two front pockets and two side seam belt loops with a matching belt. "Made in China" and "100% Polyester" are printed on a sewn-in label in the robes seam.

REMEDY: Consumers should immediately take the recalled children's robes away from children and contact Mark of Fifth Avenue. Consumers can receive a full refund of the purchase price of the garment by cutting the robes in half, taking a photo of the cut garment, and sending an email to mofaproductsafety@gmail.com with the photos. All known purchasers will be contacted.

PRODUCT/FIRM: Promotional Children's Projector Flashlights by Halo

DESCRIPTION: This recall involves five models of children's projector flashlights: Disney, Pixar, Star Wars,

Avengers and ESPN. They have a key chain on one end and a flashlight projector on the other end. The model name is imprinted on the middle of the flashlight. The flashlights are red, dark blue or light blue. They measure 3 inches long and .5 inches in diameter. The recalled flashlights were part of a Disney-branded care package that also includes a tote bag, silicone wristband, playing cards, ink pen, journal, wall decals and a set of postcards. There are four button cell batteries with model number LR41 inside the flashlight.

REMEDY: Consumers should immediately take the recalled projector flashlight away from children, stop using it, and contact Halo for a full refund and a prepaid shipping label to return the projector flashlight. Upon return, Halo will send the consumer a \$5 gift card redeemable at a major national retailer.

PRODUCT/FIRM: Baby Ruffle Rompers by Hanna Andersson DESCRIPTION: This recall involves the style Baby Ruffle Romper, the style number 66919 is written on the main label at the neck of the top. It's a 100% cotton romper with ruffles sold in Petal

Pink, Golden Hour and Juniper with a polka dot pattern in U.S. sizes from zero months to three years and Euro sizes 50-90. There are metal snaps starting from the neckline to the center of the romper. **REMEDY:** Consumers should immediately stop using the recalled Ruffle Romper and contact Hanna Andersson for a full refund. Hanna Andersson will be providing postage-paid labeling to consumers for the return of the product for a full refund. Hanna Andersson is contacting all known purchasers directly.

PRODUCT/FIRM: Angel Line Bunk Beds with Angled Ladders by Longwood Forest

DESCRIPTION: The U.S. Consumer Product Safety

Commission and Angel Line, of Laurel Springs, New Jersey, are announcing the recall of about 39,900 bunk beds with angled ladders due to a serious entrapment and strangulation hazards to children. A 2-year-old boy from Columbus, Ohio died in May 2018 after he was found unresponsive in a gap in the bunk bed ladder. The metal hook fastening the ladder to the top bunk bed frame can move away or detach from the bed frame when the ladder is lifted and create a gap of more than 3.5 inches between

the ladder step and bed frame. Children can get entrapped in that gap and strangle to death.

REMEDY: Consumers should immediately stop using the recalled bunk beds, block children's access to the bunk beds and contact Angel Line to receive a free repair kit with reinforcement brackets for the ladder. Consumers who paid for the bunk beds to be assembled when purchased will receive reimbursement for help with installing the repair kit if needed.

PRODUCT/FIRM: Infant Bath Seats by Karmas

DESCRIPTION: This recall involves Karmas Far's infant bath seats sold and marketed as a 2-in-1 or 3-in-1 booster seat for eating, bathing, and sitting up. The plastic bath seats

with a removable tray were sold in the following color schemes: yellow, orange, and white. The 2-in-1 seat measures about 13 inches wide, 17 inches deep and 12 inches high. The 3-in-1 seat measures about 14 inches wide, 18 inches deep and 16 inches high.

REMEDY: Consumers should immediately stop using the recalled infant bath seats and contact Karmas Far to receive a pre-paid label to return the products. Upon receipt of the products, consumers will be issued a full refund for the purchase price. Karmas Far is notifying all known purchasers directly.

PRODUCT/FIRM: Schwinn Electric Scooters by Pacific Cycle

DESCRIPTION: This recall involves all models of the Schwinn Tone Electric Scooter. That includes the Tone 1, Tone 2 and Tone 3 models. The scooters come in black or white and have a "T"

handlebar and an approximately two-foot-long board. The e-scooter's serial number is located on the bottom of the board.

REMEDY: Consumers should immediately stop using the recalled e-scooters and contact Pacific Cycle for a free repair kit. Consumers will need to provide the serial number of their scooter and a

mailing address. The repair kit can be installed by the consumer and includes all required tools and instructions, which are also available in video format. Pacific Cycle estimates it will take consumers between five and ten minutes to install. Alternatively, consumers can ship the e-scooter back to Pacific Cycle for repair, at no cost to the consumer.

PRODUCT/FIRM: Decorative

Mailbox by Target

DESCRIPTION: This recall involves the Bullseye's Playground Metal Mailbox. The mailbox was sold in red or white

and measures about 7 inches in length, 3 inches in width and 10 inches in height. The words "Letters to Santa" are printed on the front of the mailbox in white or black letters. The product item number is printed on the white sticker located on the bottom of the mailbox sold in stores and on the inner packaging of the two-count mailboxes sold online.

REMEDY: Consumers should immediately stop using the recalled mailbox and return it to any Target Store for a full refund in the form of a Target gift card. Consumers can also contact Target to receive a prepaid return label to return the mailbox for a full refund in the form of a Target gift card.
